1. Purpose. To identify establishments that have been declared off-limits to Armed Forces personnel by the Commanding Officer, Marine Corps Air Station (MCAS) Cherry Point.

2. Background. Declaring an establishment off-limits is a function of command which may be used to help maintain good order, discipline, and an appropriate level of health, morale, safety, morals, and welfare of Armed Forces personnel, per reference (a). Additionally, it requires off-limits restrictions be made known to all Armed Forces personnel who may frequent the area(s) in question. The Armed Forces Disciplinary Control Board (AFDCB) advises the Commanding Officer, MCAS Cherry Point regarding which establishments to declare off-limits, per reference (b). Enclosure (1) is the current list of off-limits establishments designated by the Commanding Officer, MCAS Cherry Point and is effective immediately.


3. Action

a. Commanders shall inform their personnel they are prohibited from conducting business with, and entering the premises of, the off-limits establishments listed in the enclosures. Enclosure (1) is a list of the off-limits establishments in the MCAS Cherry Point local area. Enclosure (2) is a list of the regional off-limits establishments designated by the Commander, MCIEAST-MCB Camp Lejeune.

b. The contents of this bulletin will be disseminated to all Armed Forces personnel in the Cherry Point area and will be conspicuously posted on all Cherry Point area command bulletin boards. Violation of the provisions of this Bulletin is punishable as an offense under Article 92 of the UCMJ.

c. The President of the AFDCB is responsible for publishing a current listing of those establishments/areas declared off-limits.

4. Reserve Applicability. This Bulletin is applicable to all Armed Forces personnel permanently or temporarily assigned to MCAS Cherry Point and includes all subordinate and tenant commands.

**OFF-LIMITS AREAS**

An "off-limits" area/establishment is defined as any vehicle, conveyance, place, structure, building, or area prohibited to military personnel to use, ride, visit, or enter during the period in which it may be declared off-limits. As a matter of policy, the change of ownership, management, or name of any off-limits establishment does not, in and of itself, revoke the off-limits restriction. Accordingly, the Commanding Officer, Marine Corps Air Station Cherry Point, based on the recommendations of the Cherry Point Armed Forces Disciplinary Control Board, has declared the below areas/establishments off-limits to all Armed Forces personnel. Since these off-limits areas/establishments frequently change names, signs, and identifying features, these establishments are referenced below primarily by their address and location to make them clearly identifiable. The below listed off-limits areas/establishments will remain off-limits until deleted from this list by subsequent changes to this Bulletin:

COMMANDER, MARINE CORPS INSTALLATIONS EAST-MARINE CORPS BASE  
CAMP LEJEUNE DESIGNATED OFF-LIMITS ESTABLISHMENTS

An off-limits area is defined as any business, building, place, structure, vehicle, conveyance, or area which Armed Forces personnel are prohibited to patronize, enter, visit, use, or ride. In accordance with reference (b), the installation commander has the authority to place an establishment off-limits if it is determined to be harmful to the welfare and safety of Armed Forces personnel and their dependents. Visiting these locations violates reference (b), which is a punitive order, and violators may be punished under the UCMJ. As a matter of policy, a change in ownership, management or name of any off-limits establishment does not, in and of itself, revoke the off-limits restriction. Since these off-limits areas/establishments frequently change names, signs, and identifying features, these addresses, locations and general descriptions are designed to make them clearly identifiable despite superficial changes done to them. Accordingly, the Commander of MCIEAST-MCB CAMLEJ, based on the recommendations of the AFDCB, has declared the following below areas/establishments as off-limits to all Armed Forces personnel. The below listed off-limits areas/establishments will remain off-limits until deleted from this list by subsequent changes to this Bulletin. If the off-limits establishment is a gas station, service members are only allowed to purchase gasoline utilizing pay at the pump.
