Subj: MARINE CORPS COMMUNITY SERVICES PROCEDURES FOR CATERING EVENTS AT AREAS MANAGED AND OPERATED BY MARINE CORPS COMMUNITY SERVICES

- 1. <u>Situation</u>. Facilities and areas managed and operated by Marine Corps Community Services (MCCS) are operated for the primary benefit and enjoyment of military personnel and their family members.
- 2. Cancellation. ASO 1710.4B.
- 3. <u>Summary of Revision</u>. This Order has been revised and should be reviewed in its entirety.
- 4. <u>Mission</u>. To publish procedures for the use of MCCS catering and the contracting of food prepared by outside caters.

## 5. Execution

a. <u>Commander's Intent</u>. To provide facilities that will enhance the quality of life for all personnel aboard the Air Station.

### b. Concept of Operations

- (1) Events Catered by MCCS. Contact Millers Landing at (252) 466-9067, or The Public House at (252) 466-5555.
- (2) Events Not Catered By MCCS. If MCCS or one of our third-party businesses, is unable to provide catering services due to a scheduling conflict, an outside approved source may be used. "The Directory of Sanitarily Approved Food Establishments for Armed Forces Procurement (In CONUS)" is published under provisions of NAVSUPINST 4355.4F and MCO P10110.31H. The directory lists sources that have been approved by Headquarters, U.S. Army Health Services Command. The directory is available at the following website, http://vetcom.amedd.army.mil/food.html, or may be obtained by contacting a representative of the MCCS Contracting Department at 466-6062 or 466-2042. In no instance will use of an outside

caterer be permitted for an event at Miller's Landing, or the Public House.

- (3) <u>User Agreement Contract</u>. A user agreement contract must be completed and signed prior to reserving any MCCS area; additionally, all catered events held in MCCS facilities or areas, must use an approved source. Catering contracts with outside sources must be contracted through the MCCS Contracting Office. Contracting activities related to catering are governed by reference (c).
- (4) <u>Alcoholic Beverages</u>. Under no circumstances will alcoholic beverages be provided or served by any source except MCCS, per reference (d).
