- 1. <u>Situation</u>. Medical evidence overwhelmingly shows that the use of tobacco products adversely affects health and readiness. The Surgeon General of the United States has determined that the use of tobacco is the leading preventable cause of premature disease and death. The Environmental Protection Agency states that involuntary/passive tobacco use poses a public health risk larger than the hazardous air pollutants from all industrial emissions combined. Tobacco adversely affects night vision, respiratory capacity, wound healing rates, and contributes to risk of cold injuries, including frostbite. Tobacco use is a leading avoidable public health hazard in the Navy and Marine Corps. Comprehensive guidance for the administration of the Tobacco Prevention and Control Program is needed to address this health hazard aboard Marine Corps Air Station (MCAS) Cherry Point.
- 2. Cancellation. ASO 5353.1F.
- 3. <u>Mission</u>. To implement the policies and procedures outlined in the references, and to provide additional instructions for administration of the Tobacco Prevention and Control Program aboard MCAS Cherry Point.

4. Execution

- a. Commander's Intent and Concept of Operations
- (1) Commander's Intent. The Tobacco Prevention and Control Program for MCAS Cherry Point shall provide education on the negative effects of tobacco use and intervention classes for current tobacco users. To reach the goal of decreased prevalence of tobacco use by personnel, our leaders in both the enlisted and officer ranks, must aggressively promote cessation efforts to those who use tobacco. Tobacco use "products" include smoking tobacco (e.g., cigarettes, cigars, water pipes, hookah, pipe tobacco, roll your own); Smokeless tobacco (e.g. spit, plug, leaf, snuff, dip, chew, snus); nicotine gels; dissolvables; and associated devices to include vaporizers, electronic cigarettes, electronic pipes, and electronic hookah (e.g. e-cigarettes, e-pipes, e-hookah, vapepen, pod mod); any product that can be used to deliver nicotine or tobacco; and any other and future tobacco products as classified by the FDA."
- (2) <u>Concept of Operations</u>. A thorough prevention education program must address the entire scope of Tobacco Prevention and Control. The key elements of the program are prevention, intervention, and treatment.

b. Subordinate Element Missions

(1) Commanders/Directors/Officers In Charge shall:

- (a) Permit tobacco use only to the extent that it does not endanger life or property or risk impairing non-tobacco users' health.
- (b) Reduce tobacco use, prevent tobacco use initiation, reduce non-users' exposure to environmental tobacco smoke (also known as secondhand smoke) and residue, promote quitting, and establish tobacco-free facilities.
- (c) Ensure that all military personnel receive training on the dangers of tobacco products, to include impacts to health and readiness, throughout the military life cycle to include command indoc and orientation, and as directed by the service annual general military training policies per ref (a). (NMRTC AND Semper Fit staff available to provide training).
- (d) Prohibit the use of tobacco to include cigarettes, smokeless tobacco, and Electronic Nicotine Delivery Systems (e.g., hookahs, vapor pens, all forms of electronic cigarettes, etc) use in all U.S. government owned buildings and vehicles, except where high level orders apply. Counsel and prosecute offenders as appropriate for disobeying a lawful order.
- (e) Prohibit tobacco use in and around entryways, breezeways, and windows to a minimum distance of 50 feet from the building (100 feet from areas frequented by minors) except in designated smoking areas. All designated tobacco use areas shall not encourage tobacco use and shall be located to limit visibility of tobacco use and exposure to second-hand smoke. Consider creating a smoke/tobacco free break area so that non-tobacco users may have a respite area that is free from temptation and the harmful effects of tobacco and second-hand smoke. Allow non-smokers to take as many breaks throughout the day as smokers. This action may prevent Marines from taking up smoking to get a break from work.
- (f) Consider tobacco and non-tobacco preference in the assignment of berthing spaces (barracks). Prohibit tobacco use in berthing spaces shared by tobacco users and non-tobacco users. Tobacco use will be allowed only in designated tobacco use areas.
 - (g) In establishing official designated tobacco use areas, the below criteria shall be followed:
- 1. Tobacco products are prohibited in all indoor DON facilities and must be designated tobacco product free and tobacco use is restricted to specifically designated outdoor areas.
- 2. In the case of common areas outside of buildings, the designation of tobacco use areas shall be coordinated jointly between leaders.
- <u>3</u>. When civilian employees are affected, coordinate with the Civilian Human Resources Office-East prior to designating an official tobacco use area.
- 4. All designated tobacco use areas must be clearly marked with displayed signs. Enclosure (1) may also be used for additional posting.
- (h) In support of fairness to all Marines, unit commanders are encouraged to institute new standing orders in their work spaces to stop the use of all tobacco products in these spaces. Such orders should support fairness to the smokers who already limit their tobacco intake to breaks and lunch hours and should limit the use of the smokeless tobacco and the vessels that hold their body fluids from coming into contact with others.
- (i) Sale of tobacco products will be prohibited to all those under the age of No discount sales of tobacco products, with the exception of cessation aids, are permitted. Per reference (b), Marine Corps Community Services (MCCS) shall adjust the price of tobacco products sold in Navy and Marine Corps exchanges to match prices in the commercial sector, and thereby end the five percent discount permitted by DoD policy.

(2) Medical and Dental Health Care Providers Shall:

(a) Per reference (f), uniformed and civilian personnel within Navy Medicine are prohibited from using tobacco products while in the presence of patients or while in their working environment. Because of the risk of

second- and third-hand smoke, Navy Medicine personnel, while in a duty status, shall demonstrate no visual or olfactory evidence of tobacco use.

- (b) Inquire about patients' tobacco use during routine physical and dental examinations and advise users of the health risks associated with tobacco use, the benefits of stopping, and how to obtain assistance.
- (c) Advise all pregnant tobacco users of the health risks to the fetus and how to obtain assistance to stop tobacco use.
- (d) Medical treatment facilities, personal service centers, Semper Fit Centers, and counseling/assistance centers shall provide tobacco users encouragement and professional assistance to stop using tobacco products. Aggressively promote tobacco cessation opportunities and encourage cessation programs, but take care to avoid coercion or pressure on personnel to enter these programs against their will. The Tobacco / Nicotine Cessation Program, open to, all nicotine users (who have access to the air station) is offered on an as needed basis via the members health care provider or primarily the Tobacco Cessation Facilitator at the Health Promotions and Wellness Division at the Navy Medicine Readiness Command (NMRTC), Cherry Point. - (e) Participation in tobacco cessation classes to increase the efficacy of staying off tobacco is highly encouraged. Tobacco cessation aids shall be made available to all active duty personnel through their medical provider, and do not require participation in tobacco cessation classes.
- c. <u>Coordinating Instructions</u>. This Order does not override tobacco use provisions of existing civilian collective bargaining agreements until those agreements have expired.
- 5. <u>Administration and Logistics</u>. Recommendations pertaining to the content of this Order should be directed to MCCS, MCAS Cherry Point.
- 6. Command and Signal
 - a. Command. This Order is applicable to MCAS CHERPT and its subordinate and tenant commands.
 - b. Signal. This Order is effective the date signed.
