1. <u>Situation</u>. To promulgate the appointment and responsibilities of the command liaison members to the Advisory Board for the NMCRS Cherry Point Office.

2. <u>Mission</u>. Reference (a) provides policy and procedural guidance approved by the Board of Directors for the NMCRS. Reference (b) specifies the membership of the Board of Directors and the purpose of the NMCRS. It further delineates the Commandant of the Marine Corps' policy that commanders shall cooperate fully with the NMCRS activities.

3. Execution

- a. <u>Commander's Intent</u>. It is command policy to support the local Office to the maximum extent possible and to protect the personal privacy of present and former members of the Navy, Marine Corps and their family members who seek assistance.
