1. Situation. To identify establishments that have been declared off-limits to Armed Forces personnel.

2. Cancellation. ASB 1620 dated 15 December 2016.

3. Mission. To ensure that off-limits restrictions are made known to all Armed Forces personnel who may frequent the area(s) in question, per reference (a).

4. Execution

a. Commander's Intent and Concept of Operations

(1) Commander's Intent. To ensure that all Armed Forces personnel in the Cherry Point area are aware of establishments which may conduct illegal, discriminatory, or unfair commercial and consumer practices.

(2) Concept of Operations

(a) Commanding Officers will inform personnel in their commands that they are prohibited from conducting business with, and entering the premises of, the off-limits establishments shown in enclosures. Enclosure (1) is the off-limits establishments shown in the Havelock/MCAS Cherry Point local area. Enclosure (2) is the off-limits establishments designated by the Commanding General, MCIEast-MCB Camp Lejeune and provided for service members traveling outside the MCAS Cherry Point local area.

(b) Violation of the provisions of this Bulletin is punishable as an offense under Article 92 of the Uniform Code of Military Justice.

b. Coordinating Instructions

(1) The contents of this Bulletin will be disseminated to all Armed Forces personnel in the Cherry Point area, and will be conspicuously posted on all Cherry Point area command bulletin boards.


(2) Per reference (b), the President, Cherry Point Armed Forces Disciplinary Control Board, is responsible for publishing a current listing of those establishments/areas declared off-limits. This listing is updated and published annually or as needed.

5. Administration and Logistics. The Commanding General, 2d MAW and the Commanding Officers of the Cherry Point Naval Health Clinic and the Fleet Readiness Center (East) concur with this Bulletin insofar as it pertains to members of their Command.

6. Command and Signal

a. Command. This Bulletin is applicable to all Armed Forces personnel permanently or temporarily assigned to Marine Corps Air Station, Cherry Point and all subordinate and tenant commands.

b. Signal. This Bulletin is effective the date signed.

OFF-LIMITS AREAS

An "off-limits" area/establishment is defined as any vehicle, conveyance, place, structure, building, or area prohibited to military personnel to use, ride, visit, or enter during the period in which it may be declared off-limits. As a matter of policy, the change of ownership, management or name of any off-limits establishment does not, in and of itself, revoke the off-limits restriction. Accordingly, the Commanding Officer, Marine Corps Air Station, Cherry Point, based on the recommendations of the Cherry Point Armed Forces Disciplinary Control Board, has declared the following areas/establishments as off-limits to all Armed Forces personnel. Since these off-limits areas/ establishments frequently change names, signs and identifying features, these establishments are referenced below primarily by their address and location to make them clearly identifiable despite superficial changes done to them. The below listed off-limits areas/establishments will remain off-limits until deleted from this list by subsequent changes to this Bulletin:
