North Carolina school districts received over \$1,590,800 from the Department of Education for Impact Aid related to Cherry Point.

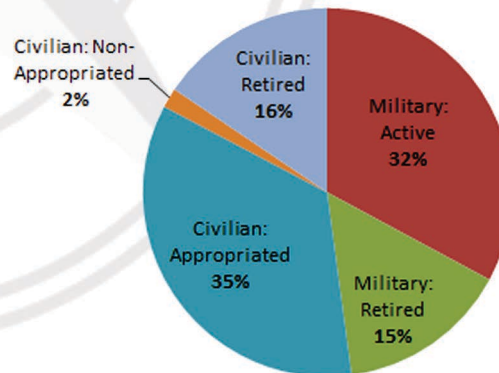

Commanding Officer's Message



It is with great pleasure that I present Marine Corps Air Station Cherry Point's Fiscal Year 2015 Economic Impact Statement. This information represents the financial force of Marines, Sailors and Civilians who live and work in this part of Eastern North Carolina.

MCAS Cherry Point continues to provide critical support to the 2d Marine Aircraft Wing, Fleet Readiness Center East and various other organizations, and just as importantly, never forgets it is part of the community that so faithfully supports our mission. So, as we enter our 75th year supporting our nation's Expeditionary Force in Readiness, we remain keenly aware of our vital role in the economic stability of the area and the overall economic health of North Carolina.

Through good stewardship of our tax dollars, a highly motivated and trained workforce, and efforts to posture our air station, ranges and outlying fields for the future, we remain committed to supporting our national defense by maintaining Cherry Point as the premier air station in the Marine Corps.

During FY15, Cherry Point's overall economic impact was \$2.01B, despite significant challenges wrought by the ongoing climate of fiscal austerity. The salaries paid to active duty, retired military, current and retired civilians held at more than \$1.215B, and over \$72.5M in contracts was awarded, with laser-like focus on preserving mission readiness for years to come.

This brochure is produced to provide a financial reference for government officials, business leaders, civic organizations and local citizens to assist with future planning and developing requirements. I believe that, altogether, our mutual cooperation will always be a key component in the success of our community and in our national defense.
